Silent Auction Closes at 4PM Sat Dec 10

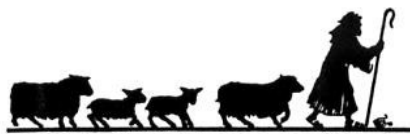
*Highest bidder will be called Sat, Dec 10 after 4pm. You must provide a number where you can be reached **SATURDAY AFTER 4PM** or next bidder will be called.*

**All trees must be picked up on Sun, Dec 11, 11am-2pm at TownMall.**

1. Silent auction participants must register to receive a bid number.
2. Must be 18 or over to bid unless accompanied by an adult.
3. Each tree has an assigned number and a bid sheet.
4. Bids begin at the opening price and may be **increased in \$5 increments**.
5. Each new bid must be written on the next blank line on the bid sheet accompanied by your BID NUMBER.
6. If you place multiple bids and are the winning bidder, be prepared to pay for all winning bids.
7. **Silent Auction begins at 10am Fri, Nov 25, 2011 and closes 4pm Sat, Dec 10, 2011.**
8. In the event of a dispute, *The Shepherd's Staff* will be the final authority. Their decision is final.
9. Winning bidders will be notified by phone on Sat, Dec 10 after 4pm.
10. If winning bidder is **NOT** reached at their provided phone number(s) on Sat, Dec 10. **The tree will be sold to the next highest bidder.**
11. **All trees must be picked up on Sun, Dec 11, 11am-2pm at the TownMall.** All trees will be picked up fully decorated.
12. Payments by the successful bidder must be made by check, cash or credit card (VISA or Master Card) at the time of pick-up. All checks should be made payable to "The Shepherd's Staff."
13. **No payment accepted and no trees distributed on Sat evening, Dec 10. NO EXCEPTIONS.**
14. All trees are auctioned "AS IS"; no refunds or exchanges.
